to consecutive terms. The motion was seconded by Mr. Schaefer. Mr. Schaefer offered an amendment that in the event of a tie vote or no election occurs, the Chair and Vice Chair would remain unchanged until an election the following December. The amended motion was accepted by Mr. Vazquez and unanimously carried, Mr. Vazquez, Mr. Schaefer, Mr. Gaines, Ms. Cohen and Ms. Yee voting yes.
