Monday, November 27, 2017

Staff of the State Board of Equalization (BOE) will hold an interested parties meeting regarding the designation of the 2018 representative period for certificated air carriers and scheduled air taxi operators.

Background

The Board is required by law to make the designation annually on or before January 15 for the forthcoming fiscal year. Based on prior informal discussions with county assessors' staff, Board staff expects to recommend that the Board adopt one week in October 2017 as the representative period for the 2018 lien date. Board staff further expects to provide the Board with several alternatives to that recommendation.¹

Staff's preference to designate one week in October 2017 as the representative period is based on an analysis of 32 years of data on monthly sales of jet fuel in California. The analysis assumes that (1) jet fuel sales are closely related to aircraft activity in California and (2) California jet fuel prices are closely related to worldwide crude oil prices. Staff believes that using jet fuel sales as a proxy for aircraft activity is reasonable since deliveries of fuel, on average, should coincide with aircraft activity.
